

WAIVER, RELEASE OF LIABILITY, AND ASSUMPTION OF RISK

I, (Parent or Guardian's Name) _____, voluntarily agree to this Waiver and Assumption of Risk regarding (Child's Name) _____'s participation in the COMPUTER TRAINING INSTITUTE OF CHICAGO'S ("CTIC") TECHMEN CONFERENCE ("Conference"), which is scheduled to occur on June 17, 2017, from 10 am to 2 pm. "CTIC" includes all principals, agents, affiliates, licensees, successors, representatives, and/or assigns of Computer Training Institute.

In consideration for the opportunity for my child to participate in the Conference, **I agree to the following Waivers, Release of Liability, and Assumption of Risk:**

- 1) I agree that I am responsible for organizing my child's transportation to and from the Conference.
- 2) I give my child permission to engage in all CTIC-sponsored activities at the Conference.
- 3) I agree that all images and media collected from the Conference – including those involving my child – may be broadcast or published in all media forms. I consent to the use of all media involving my child that CTIC collects at the Conference, and I release CTIC from all claims arising out of or relating to the use of this media. I also waive all rights to all photos and other media involving my child at the Conference. I furthermore waive any rights of compensation based on any use of such media.
- 4) I understand that there are certain risks and dangers association with my child participating in the Conference. These risks include, but are not limited to: falls which can result in injury; injury due to the acts or omissions on the part of CTIC; and/or injury of any kind due to a child's improper behavior. I am aware that any of these above mentioned risks may result in injury. I willingly assume full responsibility for the risks that may result from my child's participation at the Conference, and I fully assume the risk involved with him/her participating in the Conference.
- 5) I agree to release CTIC from any and all liability arising out of my child's participation in the Conference. I further release CTIC from all claims that may arise involving my child, including those allegedly attributed to the negligent acts or omissions of CTIC to the fullest extent permitted by law. This agreement shall be binding upon my successors, representatives, heirs, executors, assigns, transferees, and me.
- 6) I understand that, during the Conference, my child will be instructed regarding their behavioral guidelines, and I release CTIC from all injuries which may result from my child's failure to follow these guidelines.
- 7) I acknowledge that the conference is from _____am to _____pm and agree that CTIC is in no way responsible for any injuries, damages, or other occurrences that may happen before or after the scheduled conference time.

I give full permission for CTIC to administer first aid, and in case of serious illness or injury, to call for medical and/or surgical care for the child and to transport the child to a medical facility. **I have read, understand, and fully agree to this Waiver, Release of Liability, and Assumption of Risk. By signing below, I agree to the above clauses, and release CTIC from all potential claims that may arise out of my child's participation in the Conference. I further agree to waive all potential claims against CTIC arising out of my child's participation in the Conference.**
